Dr. Entwistle invited Amanda Rei, K-12 Guidance Specialist, to update the School Committee on the work she is doing to implement the bullying prevention and intervention plan. She shared a "tutorial" on bullying that she created for the web site that is under development.

Dr. Entwistle updated the School Committee on the FY12 Budget. He noted that we are very grateful for the additional revenue that will allow us to achieve approximately phases 1-3 of the 6-phase restoration plan. However, he also noted that the budget is less than level services, and he highlighted systems, structures, and programs that will be restructured.

Dr. Entwistle updated the School Committee on Community Dialogue II that was held on May 4, 2011. There were 60 dialogues, and approximately 350 participants. The Leadership Council will begin

working with the dialogue proceedings at their meeting on May 12, 2011. The Leadership Council's work of refreshing the Long Term Goals, Targets, and 18 Month Improvement Strategy will continue on May 19. The Leadership Council will present their work to the School Committee at the workshop meeting on May 24, 2011.

Ms. Darias updated the SC on the planning of the Professional Learning Team Conference for the professional staff of the Belmont Public Schools. This is the culminating conference at which all PLTs will share their findings, either in an exhibit or a presentation. The conference will be held in two locations, Belmont High School and Chenery Middle School.

2.5 Chairman's Report

Ms. Graham updated the School Committee on the Interim Superintendent Search. Ms. Graham listed the members of the screening committee, and the timeline for the work. The screening committee attended a training session last Friday evening, May 6, 2011. Information about the search is posted on the Belmont Public School web site.

The Belmont Special Needs Advisory Council will give out its Appreciation Awards at a ceremony on May25, 2011 at 7:30 p.m. in the CMS Cafeteria.

The Lillian Blacker Award and the Denis Fitzpatrick Book Award will be presented at a ceremony on May 18, 2011 in the Peter Holland Library at Belmont High School.
