


New library time line, August 2012





 - Grove street


Field usage for "affected" fields


- Spring (3d Mon. in March to mid-June):

- Night-time use of SoftBall field





- Incinerator site

SC concerns -- Incinerator

- 1. Title 9
- 2. Medical/trainers for home athletic events
- 3. Shelter for inclement weather
- 4. Rec. programs (though that may be a community concern, rather than school)
- Covering recurring added costs
- 6. Maintenance staff access
- 7. Power for score boards, if appropriate
- 8. Reservation of rights

Additional costs


- Total projected cost per season: \$21,450.00
 - Transportation: 55days x \$255.00 = \$14,025.00
 - Trainer coverage: 55days X 3hours/day@ \$45.00perhour =\$7,425.00

Incinerator upsides and downsides

- Upsides
 - Bigger (regulation) field
 - More training staff
 - (New library)
- Downsides
 - Transportation inconvenience
 - Cost (transportation and staff)

Underwood – concept

- Sale of land at incinerator frees up \$\$\$ for capital projects
 - Issue: can we? Still checking
- Use that \$\$\$ to build a practice field where the pool is, move the pool up the hill, and move the playground to the top of the hill

Underwood

- Upsides
 - Great location when viewed solely from HS perspective – "on campus"
 - Bigger project
- Downsides
 - Unresolved legal and political issues
 - Field size?



- School Committee vote in September, to effect that the School Committee will "transfer" land to Town, provided an alternative field is made available across the street or at the incinerator site
- Followed by fund-raising to help with a building committee
- TM vote in November
