Ms. Graham welcomed Ms. Shuster to the School Committee.

2. **BUSINESS MEETING**

2.1 Citizen's Concerns

There were no citizen's concerns.

2.2 Adjustments to the Agenda

There were no adjustments to the agenda.

2.3 Chair's Report

Ms. Graham updated the Committee on recent community, school, and sporting events that have taken place or will take place in the near future.

2.4 Superintendent's Report

Dr. Kingston acknowledged the receipt from the Massachusetts School Building Authority (MSBA) indicating they had received the Statement of Interest for Belmont High School.

Dr. Kingston presented slides of photographs of the new Butler Playground. They photos showed two entry stones. The proposal is to place names of major donors on one stone and on the other it will read Butler Community Playground – 2012. He stated that the final surfacing will be done over the next couple of weeks. The slide will be replaced and swings will be added. Dr. Kingston noted that the playground is already in operation and there will be a dedication ceremony at some point in the future.

Dr. Kingston discussed the April 1 enrollment numbers which have not changed much since March. The total number of students is 4,146. Dr. Kingston stated that he will continue with capping

enrollment at Wellington. He stated that the Class Size Advisory Committee concluded that redistricting is a long term strategy.

Ms. Darias shared with the School Committee the list of Foundation for Belmont Education (FBE) Learning Excellence Grants that had been submitted for the March cycle. She explained that teachers who will be receiving grants have been notified and stated that she and the staff are grateful for the support and opportunities that the grants provide. Ms. Darias explained that prior to this grant cycle, teachers attended a workshop to learn how the work of the Foundation for Belmont Education is done and how to propose projects to be funded.

Ms. Darias provided an update on the new 8th grade social studies course. A year ago, the National History Day project was removed as a required part of the curriculum to allow the expansion of the Early American History course to prepare students for the new core standards on reading, writing and research. Ms. Darias explained that there has been significant improvement in student writing, since the beginning of the year as a result. Teachers feel strongly that all students are finding success in the project. Ms. Darias noted that there is still a National History Day Club for students who wish to take part and noted their success this year.

2.5 Director of Finance, Business and Operations Report

There was no report from the Director of Finance, Business and Operations.

He thanked the Warrant Committee Education Subcommittee for their faith and interest in the Belmont Public Schools.

Ms. Graham stated that the Policy Subcommittee will be reviewing the use of breathalyzers at Belmont High School to determine if a procedure needs to be included in the School Handbook.

4.4 Curriculum & Instruction Subcommittee

Ms. Graham stated that the Curriculum & Instruction Subcommittee will be meeting within the next couple of weeks to review revisions to the grade 7 social studies geography segment.

4.5 Capital Budget Subcommittee

Ms. Lougée stated that the Capital Budget Subcommittee met on March 28 to review requests from the various departments. They will discuss prioritizations at their next meeting.
